中国の超硬材料関連品目に関する輸出規制の施行の延期について (Please scroll down for the English version)

拝啓 平素は格別のご高配を賜り、厚く御礼申し上げます。

中国当局は 2025 年 11 月 7 日、「超硬材料関連品目の一部(工業用ダイヤモンドパウダー等)に関する輸出規制 (2025 年 10 月 9 日公布)」を 2026 年 11 月 10 日まで延期すると公表しました。

これにより、中国から輸入されるダイヤモンドパウダーの供給懸念は一先ずは回避することができるものと考えられます。当社といたしましては、今後も調達先の多様化を含め引き続き十分な在庫を確保して参りますとともに、業務提携先であるトラストウェル社と協働して各種の対応を継続して参ります。

なお、当社が国内で自社生産しております多結晶ダイヤモンドパウダーにつきましては、将来の輸出規制導入による影響を懸念されるお客様から多数のお問合せを頂いております。当社の中期経営計画の下で、多結晶ダイヤモンドパウダー増産に向けての体制構築を進めているところでありますが、お客様におかれましてはご要望の粒度や形状、使用目的や数量等に関しまして出来る限り前広にご相談頂きたいと存じます。お客様のご理解とご協力を賜りますようお願い申し上げます。

The Effects and our Response to Export Restrictions on Chinese Superhard Material Related Items

We wish to inform you that the Chinese authorities have recently announced that the export restrictions on certain superhard material products (including industrial diamond powder), which were due to come into effect on November 8th, 2025, will now be suspended until November 10th, 2026 and we do not foresee any supply disruptions soon. However, if such restrictions were to be implemented, we could not guarantee the smooth procurement of diamond powder that we have experienced previously.

Regarding the monocrystalline diamonds handled by our company, the majority are currently imported from China. As we have sufficient stock of monocrystalline diamond powder to meet customer demand, we continue ensuring adequate inventory levels by diversifying our procurement sources while monitoring future developments in export regulations to meet customer demand.

Regarding polycrystalline diamond powder, we do not anticipate a direct impact from the regulations as we undertake integrated production, from synthesis to the finished product, at our domestic manufacturing facility. In the meantime, we do foresee the potential for future increases in demand. We kindly request that customers consult with us well in advance regarding their required particle size, shape, quantity and other specifications.

Furthermore, as part of our medium-term management plan, we are implementing systems to increase the production of polycrystalline diamond powder. We believe this will enable us to meet our customers' growing demands.

Although future regulatory trends are uncertain, we will continue to gather information diligently and collaborate with our business partner, Trustwell, to monitor these developments. We kindly ask for your understanding and cooperation regarding this matter.
